

**Workplace Tobacco Policy Result  
May - December 2002  
Little Sandy District Health Department**

The purpose of the survey was to assess the number and type of tobacco policies, as well as tobacco prevention education, in manufacturing companies located in the Little Sandy District Health Department area. Results will be used to determine opportunities for workplace health promotion in this district.

In the Little Sandy District, 2 manufacturers participated in a telephone survey conducted by the Tobacco Prevention Coordinators in collaboration with the research staff at the University of Kentucky (50.0% participation rate). The mean number of employees was 375.5. On average, 87.5% of the employees were Caucasian, and 84.0% were male. The TOTAL column represents 625 manufacturing companies in 50 health department service areas.
