

Workplace Tobacco Policy Study Results
May - December 2002
Bourbon County Health Department

The purpose of the survey was to assess the number and type of tobacco policies, as well as tobacco prevention education, in manufacturing companies located in the Bourbon County Health Department area. Results will be used to determine opportunities for workplace health promotion in this district.

In Bourbon County, 8 manufacturers participated in a telephone survey conducted by the Tobacco Prevention Coordinators in collaboration with the research staff at the University of Kentucky (100.0% participation rate). The mean number of employees was 175.8. On average, 91.8% of the employees were Caucasian, and 58.0% were male. The TOTAL column represents 625 manufacturing companies in 50 health department service areas.
